

TERMS AND CONDITIONS LA TILDE

This document sets out the rules and guidelines for the use of the website **www.latilde.co** and its related services, including newsletter subscription.

A. General Information

- **Website:** **www.latilde.co** (hereinafter, "the Site" or "La Tilde").
